Sir,

With reference to your application on the subject  
circled above, I am directed to convey the permission of the  
Director of Education, Delhi to your society to establish a  
new School from class Ist to VIIIth (without aid) in Zone-25  
of the District-West, subject to the following conditions:-

1. That the provisions of DSE Act, 1973 and the rules framed  
thereunder shall be observed by the society.
2. That the management of the school will fulfill all the  
conditions laid down under Rule 50 and will provide all  
the facilities given in Rule 51 of DSE Act, 1973 to the  
institution.
3. That the management of the school will get the scheme  
of management approved from the department immediately.
4. That only qualified and trained teachers will be appointed  
Govt. S. C. & L. alongwith all allowances will be paid to  
the teaching and non-teaching staff through crossed cheque  
as per the requirement of section 10(i) of DSE Act, 1973.
5. That the management of the school will not ask for grant-  
in-aid from the department.
6. That the school will not run for the profit of any individual  
association or group of persons.
7. That in case at any time the management of the school is  
unable to run the school moveable and non-moveable property  
of the school will be transferred in the name of Director  
of Education, Delhi.
8. That all the recognised classes shall be run at one  
place only.
9. That the management of the school will apply for grant of  
recognition of the school under DSE Act and Rules, 1973  
separately and recognition will not be granted unless  
statutory provisions of section 4(i) (a) to (f) read with  
rules 50 and 51 are fulfilled.

That the school shall be run under the control of Rao  
Man Singh Educational Society (Regd.), Delhi and suitable

suitable building on the land allotted to the society, as  
declared as per the specification of the department within  
three years.

11. That adequate and sufficient accommodation of 12 sq.ft. per student shall be provided for class-room. The normal size of the class-room will be 24' X 20'. No other activity other than education shall be run.

If recognition for the proposed school is not sought after fulfilling all the above conditions within a period of three years, this permission to run a new school shall be treated as cancelled.
